- VI. Presentation of the 2024-2025 General Fund and Special Revenue Budgets
 Jan reviewed with the board. The actual versus budgeted amounts for last school year
 were due July 31st. Jan advised that the February count of students, reviewed to determine
 if budget should be revised during the school year. Budget narrative will be presented at
 next month, meeting. Items she pointed out to the board: There have been changes in

 meeting.

Changes include elimination of Assistant Athletic Director, adjusted power lifting stipend, added soccer-boys only this year. They will look into adding a girls' soccer team possibly next year.
