Dear Parent or Guardian:

D'Arbonne Woods Charter School participates in the National School Lunch Program by offering nutritious meals every school day. Full pay students may buy lunch for \$3.00 and breakfast for \$2.25. Eligible students may receive meals free of charge or at the reduced-price. You or your children do not have to be U.S. citizens to qualify for free or reduced-price meals. You must fill out a new Free/Reduced Lunch Application at the beginning of each school year to see if you qualify. Applications are available at our front desk any time throughout the school year. Payments

We ask that families pay up front for student meal purchases when possible. This helps the lines move quickly, giving students more time to enjoy their meal. There are multiple options to make payments to your student's lunch account:

Payment Methods

- In person payments can be made daily in the cafeteria during meal service. Please note that change will not be made. The entirety of the payment will be added to the students' account.
- We accept cash or checks in exact amounts.
- Families can add money to their student's lunch account daily/weekly/monthly via the online payment portal at mymealtime.com.

Charges/Balances

If a student takes a meal they will be charged for it. We encourage families to have a conversation with students so they know whether they can participate in the school meal program.

D'Arbonne Woods Charter School will allow students to charge a negative balance to their lunch account. Once a week, balance notifications will be sent to families. The balance statement will notify you of the current status of your student's lunch account. The balance statement will also include instructions for making payments (same as above).

If your family is experiencing a financial setback, please contact us at the school at (318) 368-8051 ext 6017 so we can help. We are willing to work with you to develop a payment plan for your lunch account.

Also, families may submit a free/reduced lunch application at any point during the school year. We can assist you in applying for free or reduced lunch if your income situation has changed mid-year.
